01. a. Call to Order

J. Visneskie Moore called the meeting to order at 10:00 a.m.

J. Visneskie Moore welcomed Mr. Daniel Janke, as a publically appointed member, to the Board.

d. Delegations

i) Vector-Borne Disease

- Lyme
 - West Nile Virus

Greg Kirke, Coordinator, Environmental Health, gave a slideshow presentation, *Vector-Borne Disease (West Nile Virus and Lyme Disease)*.

Some of the key points included in the presentation were:

- That protection is the best defence ("fight the bite"), by using DEET, wearing long sleeves and long pants, tucked into socks
- That the above defence be continued throughout deer season
- That a *Lyme Disease Update* letter was sent to health care providers in Renfrew County and District
- That Arnprior is considered an at-risk area for Lyme Disease.

ii) Flooding

Mike Grace, Acting Manager, Environmental Health, gave a slideshow presentation to the Board, *Renfrew County and District Flooding - 2017 - Health Unit Response*.

Issues following flooding include:

- Safe drinking water (private wells)
- Malfunctioning septic systems
- Exposure to flood waters
- Indoor air quality (mold)
- Electrical safety
- Clean-up measures.

Mike Grace answered questions raised by the Board.

iii) "Water Does Wonders"

Carolyn Froats Emond, Registered Dietitian, gave a slideshow follow-up presentation, *Water Does Wonders Pledge*, to the Board, for the *SipSmart!™ Ontario – Renfrew County Program*. She recommended that Board endorse the GOLD level pledge at <u>www.waterdoeswonders.ca</u>.

Possible next steps were outlined as:

- 1. MOH send notice of signing pledge to Ontario Boards of Health, alPHa, Ontario Society of Nutrition Professionals in Public Health, provincial Healthy Kids Community Challenge projects
- 2. MOH send notice of pledge signing and challenge Renfrew County HKCC project partners (400+) to take the pledge
- 3. BOH members support public health efforts to reduce availability of sugary drinks in municipal and recreation facilities, schools and day cares

iv) Fentanyl Update

A slideshow presentation, by Vicki Benoit, Acting Manager, Clinical Services, was a follow-up to the staff presentation at the Regular Board meeting on Tuesday, April 25, 2017 - *Opioid Overdose Prevention and Response*.
