Health Protection

Harm Reduction Enhancement

Across Ontario, overdoses related to opioids are increasing, and Renfrew County and District is not immune. Locally, there was an increase in the number of opioid related overdoses, from 31 in 2016 to 50 in 2017.

In response, RCDHU conducted key informant interviews with stakeholders to identify some of the issues our community is faced with. Out of those consultations, challenges identified included a lack of services, difficulties identifying clients that are opioid users, a large geography to service, a lack of transportation for clients, and the drug using population feeling stigmatized.

Renfrew County and District Health Unit is working with a broad base of partners to build sustainable community outreach and response activities to address drug and opioid-related challenges. The Harm Reduction Enhancement Program aims to: develop a local opioid response plan, conduct training for naloxone use and distribution, as well as develop a comprehensive surveillance and opioid overdose early warning system for RCD.

The Spring Flood

2017 was a year of record flooding in Renfrew County and District (RCD). Approximately 825 private homes and cottages were affected and 30 residents evacuated due to rising water levels in our lakes, rivers and reservoirs.

Renfrew County and District Health Unit environmental health staff was immediately engaged in flood management and mitigation of health hazards caused by the excess water. Topics such as mould, well water and septic system concerns, property damage, and vector borne disease fears were fielded by public health inspectors. The health unit added a temporary private drinking water pickup/drop-off location to meet the demand for private water testing in the Killaloe area. Temporary water sample points on Golden Lake were established in 2017 to monitor levels of E. coli bacteria.

Public health inspectors also acted on a higher demand for inspections of homes and businesses to detect mould and to assist in determining appropriate corrective steps to assist with the cleanup of affected areas.

Many routine small drinking water system inspections were delayed in order to respond to the flood impacts. This helped ease demand on affected operators while they were actively cleaning up their properties in response to the situation.

The health unit was constantly engaged with key stakeholders during the flooding through coordinated Emergency managers meetings. Lessons learned from this flooding event will help RCDHU be better prepared for any future flooding event.

West Nile Virus

Renfrew County and District Health Unit started trapping and testing mosquitoes for West Nile Virus (WNV) in 2002. For the first time ever in RCD some mosquitoes tested positive for WNV. These mosquitoes were trapped in Laurentian Valley and Pembroke. As a result, the health unit issued a warning to residents advising of the presence of West Nile Virus and how to minimize your risk of becoming infected.

West Nile Virus not only causes problems for those who are infected but provides public health professionals with a means of tracking environmental changes which have an impact on population health.

There were a total of 50 mosquito pools tested for West Nile Virus in 2017.

Water Does Wonders

Studies confirm, children are drinking too many sugary drinks which harms their health. Everyone can help by making tap water easier to access and by not serving or selling sugary drinks to children - in the home, in schools and in communities.

The health unit, in partnership with the Healthy Kids Community Challenge and local elementary schools, mobilized a Sip Smart!™ Ontario campaign in 2016 and this initiative continued into 2017. As part of this campaign teachers received lesson plans for grades 3 to 7, posters, parent factsheets and newsletter inserts to teach children and their families about making healthy drink choices. Five schools shared their campaign stories and received water dispensers to use at school events.

The Renfrew County and District Health Unit Public Health Dietitian provided leadership and support in the development of the Water Does Wonders Pledge, www.waterdoeswonders.ca, which complements Sip Smart!™ Ontario. The site guides families, workplaces, municipal organizations, recreation centres, and day cares to "Take the Pledge" and sip more water and reduce sugary drinks.

The Board of Health endorsed the Sip Smart[™] Ontario campaign and took the Water Does Wonders Pledge at the gold level - to promote water and not sell, provide or promote sugary drinks.

Fentanyl and Opioid OverdoseAwareness

Illicit fentanyl is a highly potent opioid known to be deadly in a small amount. Renfrew County and District Health Unit, along with, County of Renfrew Paramedic Services, Ontario Provincial Police, Ontario Addiction Treatment Centre, Addiction Treatment Services, and the Renfrew County Youth Network have worked collaboratively to address this issue head on.

In March, the "Don't Lose a Friend" Algonquin College Forums were held in collaboration with Algonquin College Waterfront Campus, where students shared that "the topic was relevant and a concern in the community".

In April and June, six open community sessions on fentanyl and overdose were held throughout Renfrew County and District as part of an overdose prevention plan. These "Town Hall" style sessions were open to everyone and included a panel of health professionals and community partners who presented on the topics of opioids and illicit fentanyl, the naloxone program and kits, the emergency services perspective and how to talk to your kids about drugs. Each session was followed by a speaker with a lived experience.

The health unit continues to work with partners to address the issue of fentanyl overdose and opioid use in Renfrew County and District.

Renfrew County Youth Network

The health unit provides leadership and brings youth engagement expertise to the Renfrew County Youth Network (RCYN), a dynamic collaborative of 52 youth serving agencies, youth and community members that support young people 12-25 years to be healthy and resilient throughout Renfrew County and District.

The RCYN planned, implemented and hosted the annual Amplify! Youth Summit held this year at Wilderness Tours for high school aged youth. Dr. Matt Bellace was the keynote speaker promoting the theme "How to Find Your Natural High" which encouraged youth to change attitudes about alcohol and drugs. The summit empowered youth to "get high" in safe, positive and natural ways. Attendance was once again very strong; 140 youth and 30 adult allies participating in this event. The main goal of the summit was to support mobilization of ten Amplify! Youth Leadership Projects in local schools and the community to enhance youth well-being and resiliency.

RCYN youth members and an adult ally raised awareness about the importance of a local youth strategy and Amplify! by providing a delegation to County Council and a presentation to the Board of Health.
