2018 RCDHU Audited Financial Statements Presentation

A hard copy of the financial statements was distributed to Board Members, at the meeting. K. Black, CPA, CA, Scott Rosien Black & Locke, presented the *Financial Statements of Renfrew County and District Health Unit Year ended* <u>December 31, 2018</u> (RCDHU Audited Financial Statements). Black stepped through the statements, page by page and answered questions raised by the Board, as they arose.

At this point in the meeting, C. Trombley provided an update to the Board on the activation of RCDHU's *Emergency Management Plan*, in response to flooding occurring

in Renfrew County and District. The *Emergency Management Plan* was activated on Monday, April 29, 2019 at 2:00 p.m.

"In accordance with the Health Protection and Promotion Act (HPPA), Revised Statutes of Ontario, 1990 (c.H.7) whereas Boards of Health are required to provide mandatory health program and services:

- 1. Community sanitation, to ensure the maintenance of sanitary conditions and the prevention or elimination of health hazards.
 - 1.1. The provision of safe drinking water by small drinking water systems.
- Control of infectious diseases and disease of public health significance, including provision of immunization services to children.

Residents of Renfrew County and District are at risk of disease, infection as well as other physical and mental health issues. The risks are far reaching and include those directly affected by the flooding as well as volunteers, emergency service workers and geographically isolated families and individuals."

The Emergency Management Plan included the coordinated efforts of RCDHU staff members with possible reassignments to other duties.

Some of the key public health messages addressed included:

- Personal safety in flooded homes
- Food safety during and after flood conditions
- Drinking water
- Well maintenance
- Septic systems
- Hand hygiene and personal protection
- Mental health during stressful times.

Packages of printed information will be delivered by RCDHU staff members to the affected seven municipalities who declared states of emergency (Greater Madawaska; Horton; Killaloe, Hagarty and Richards; Laurentian Valley; McNab/Braeside; Petawawa; Whitewater Region).

A press conference is scheduled for Friday, May 03, 2019.
