As a result of discussions by the Committee in the closed meeting the following four items were brought forward:

Contract for Acting Medical Officer of Health—January 2023
At the direction of the Governance Committee, the Chair and the Acting
Chief Executive Officer entered into discussions with a potential Acting
Medical Officer of Health.

Dr. Ian Gemmill, MD, CCFP, FCFP, FRCPC, has agreed to enter into the MOH(A) contract with RCDHU, for the period from January 1, 2023 to April 30, 2023. Only minor updates were made to the existing contract and no substantial changes were made to the remuneration section.

The Committee is grateful to Dr. Cushman for his initial outreach to Dr. Gemmill and we would look forward to welcoming him to RCDHU, as our Acting Medical Officer of Health, in the new year.

b. RFP Results, Discussion and Recommendations

H. Daly, Acting Chief Executive Officer/Director, Corporate Services, reported to the Governance Committee that five organizations were contacted. Two agencies submitted their proposals within the timeframe,

responding by 2:00 p.m. on October 17, 2022. These agencies were FeldmanDaxon Partners Inc. and Legacy Executive Search Partners.

The written submissions were independently reviewed and scored by the Acting Chief Executive Officer/Director, Corporate Services, the Director, Health Promotion and the Director, Health Protection.

The following is the summary of consolidated scores by criteria and total:

Both are excellent companies, and the totals were close. Legacy Executive Search Partners offered a longer guarantee period and a faster start time.
