Dear Parent/Guardian:

Students attending Ontario schools must have proof of immunization against certain diseases. Renfrew County and District Health Unit (RCDHU) is required to collect this information by law, [the Immunization of School Pupils Act, 1990](#). Refer to the 'Guidelines for school entry' information sheet for details.

Schools or Health Care Providers do not send us Immunization Records. It is the parent/guardian's responsibility to send it to public health, Renfrew County and District Health Unit. If you do not have a copy, contact your Health Care provider to obtain one.
